## SUBJECT: Procedures for Exemption of For-Profit Entities Giving or Selling Food for the Benefit of a Nonprofit Association

The California Retail Food Code (Cal Code), Section 113789, exempts from permitting for-profit entities that donate food to a nonprofit association under specific circumstances. Specifically, this section exempts from regulation:

"...A for-profit entity that gives or sells food at an event that occurs not more than three days in a 90-day period for the benefit of a nonprofit association, if the for-profit entity receives no monetary benefit, other than that resulting from recognition from participating in an event."

Attached are documents to be completed by the for-profit entities requesting exemption, and documents to be completed by the nonprofit association receiving the benefit. Both sets of documents must be received in order to be considered for exemption.

By requesting that the for-profit entities providing food and beverages be exempt, the event would not be considered a Community Event as defined by the Cal Code. All of the food and beverage given away or sold at your event will be provided by the non-profit entities that are requesting exemption.

These documents must be filled out completely and submitted to the Environmental Health Division (EHD) by the nonprofit association sponsoring the event at least 30 days prior to the event in order to be considered for exemption. If the EHD determines that the event is exempt from permitting, EHD will not be conducting inspections of the food and beverage vendors operating at this event. Accordingly, this Division recommends that you obtain the guidance of a professional Environmental Health Specialist or other inspection service to help ensure healthful, sanitary and safe conditions for members of the public attending the event. EHD will contact you if any questions arise regarding the documents submitted.
