In compliance with Title 27, California Code of Regulations, Section 21660.4(b), the Ventura County Environmental Health Division acting as the Local Enforcement Agency (LEA) participated in a Director's Hearing (Hearing) held by the City of Ventura Planning Commission on December 15, 2022. The Hearing was for the approval of an amendment to Use Permit to increase the volume of solid waste and vehicle trips at an existing recycling facility on a 7.81 acre site.

Description of the SWFP Revision:

GCR proposes a change in permit limits to increase both the volume of solid waste and vehicle trips. The current permit limit of 1,600 tons per day (TPD) will be changed to a maximum of 2,000 TPD, and the current permit limit of 496 vehicles per day (VPD) will be changed to a maximum of 1,000 VPD. An Addendum No. 1 to the previous MND (EIR-2355) was prepared pursuant to the Environmental Quality Act (CEQA) Guidelines Section 15164. The Addendum involves revisions to an existing recycling facility to increase the volume of solid waste and vehicle trips. The revisions are within the boundaries of the previously approved recycling facility amended on May 21, 2002, by the Planning Commission. The LEA determined that the above proposed changes were significant thus requiring a revised SWFP.

Purpose of the Meeting

The Hearing held on December 15, 2022, was for any interested parties to learn more about the proposed amendment to Use Permit and proposed revision of the SWFP, and to provide comments to the LEA. The meeting was strictly informational with no official decision made at the meeting regarding the SWFP application. A formal determination must be made by the LEA and concurrence by California Department of Resources Recycling and Recovery (CalRecycle) within 120 days of permit completeness.
