Consider Landmark Designation for Historic Property

The Ventura County Cultural Heritage Board (CHB) will consider designation of property as Ventura County Landmark No. 183, in accordance with Section (1365-1) et seq. of the Ventura County Ordinance No. 4604. The property contains an approximately 110-foot-tall steel oil derrick with a square shape, narrowing towards the top. The derrick was most likely built in 1954 and is the most prominent feature of the former refinery site, one of the first oil refineries in the area. The significance of the property will be evaluated for its association with events that have made a significant contribution to the broad patterns of Ventura County. The Landmark designation would apply to the derrick structure. The property is located at the following address:

You are hereby notified of a public hearing to be held before the CHB to review this consideration. At this hearing, there may be presentations by the applicant, the property owners, and staff with an opportunity for any interested person or authorized agent to comment on the item.

Environmental Review: This application is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15308 which is consistent with a Class 8 exemption (Actions by Regulatory Agencies for Protection of the Environment).

Notice is hereby given that the County Ordinance Code authorizes the CHB to designate the above property as a Ventura County Landmark once a notice is given to the property owner and a public hearing is held on the matter. The CHB is the final decision-making authority on the landmark designation where the property owner has no objection.
