2. <u>PLEDGE OF ALLEGIANCE TO THE FLAG OF THE UNITED STATES OF AMERICA</u>

3. <u>DISCLOSURES AND EX-PARTE COMMUNICATION</u>

Acting Chair Francis disclosed that he had communicated with Board Member Hundley regarding a private matter, unrelated to an item within the purview of the Mobile Home Park Rent Review Board (MHPRRB).

4. <u>PUBLIC COMMENT ON CONCERNS WITHIN THE AUTHORITY OF THE COUNTY RENT CONTROL ORDINANCE</u>

Liz Cole with the Golden State Manufactured-Home Owners League (GSMOL) and Golden Oaks Mobile Home Park noted her thanks to the MHPRRB for continuing to hold remote hearings.

5. APPROVAL OF MINUTES

Board Member Hundley made a motion to approve the June 21, 2021 meeting minutes. Acting Chair Francis seconded the motion. Motion passed 4-0.

Dillan Murray, Staff, clarified that Board Members who did not previously attend a hearing may still vote to approve the minutes for that hearing or may vote to recuse themselves. According to the MHPRRB Bylaws, a quorum is required to conduct a hearing and a majority of the MHPRRB's total voting members is required for a decision.

6. COMMENTS FROM RENT REVIEW BOARD MEMBERS

Board Member Martinez introduced herself to the MHPRRB and provided an overview of her background in ministry work, housing issues, and mobile home affairs in the City of Ventura.

Board Member Cass introduced himself and noted that he is a mobile home resident in the City of Ventura.

Other Board Members did not have anything to report.

7. COMMENTS FROM PLANNING STAFF

Dillan Murray, Staff, reported that the Planning Division has approved 13 ministerial rent increase applications for 2021, with one application currently pending.

Tricia Maier, Staff, responded to an inquiry from Board Member Martinez as to whether meetings of the MHPRRB could be held at the mobile home parks. Ms. Maier noted that, consistent with State and local health orders, the County of Ventura currently requires public hearings be held remotely and the MHPRRB will continue to do so for the foreseeable future. However, Ms. Maier noted that an agenda item regarding this matter could be added at the next regularly scheduled meeting for discussion purposes.

8. ADJOURNMENT

At 2:28 p.m., Board Member Hundley made a motion to adjourn the meeting. Acting Chair Francis seconded the motion. Motion passed 4-0.

Staff Report and Recommendations Mobile Home Park Rent Review Board Hearing on November 17, 2021, Item 6

I. REQUEST:

A request to review the preliminary Mobile Home Park Rent Review Board (RRB) 2022 meeting schedule and review and consider adoption of Resolution RRB21-001 (Exhibit 1) authorizing remote teleconference meetings of the RRB for a 30-day period pursuant to Government Code section 54953, subdivision (e), of the Ralph M. Brown Act.

II. <u>DISCUSSION:</u>

In response to the declared state and local emergencies due to the novel coronavirus, and in accordance with the Governor's Executive Order N-29-20, the RRB began conducting remote public meetings in May 2020 using video conference and teleconference formats. These modifications set to expire on September 30, 2021, Assembly Bill 361 (AB 361) was signed into law by the Governor on September 16, 2021 amending the Brown Act to allow fully virtual board meetings during a state of emergency.

Pursuant to AB 361, all legislative bodies may continue to meet virtually without having to comply with the existing teleconferencing requirements under the Brown Act (e.g., Gov. Code, § 54953, subd. (b)) provided the requirements set forth in Government Code section 54953, subdivision (e), are satisfied. AB 361 applies to every County board, committee, or commission subject to the Brown Act, which are called "legislative bodies."

Until January 1, 2024, legislative bodies may continue to use live video and teleconferencing for public meetings without complying with the existing teleconferencing requirements imposed by the Brown Act in any of the following circumstances:

- The legislative body holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing;
- The legislative body holds a meeting during a proclaimed state of emergency for the purpose of determining, by a majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or
- The legislative body holds a meeting during a proclaimed state of emergency and has determined, by majority vote, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees. (Gov. Code, § 54953, subd. (e)(1)(A) through (C).)

If a legislative body wants to continue meeting virtually as authorized by AB 361, the legislative body must make the required findings every 30 days after its first post-October 1, 2021, virtual meeting. When a legislative body holds a meeting remotely pursuant to AB 361, it must comply with all the requirements set forth in Government Code section 54953(e)(2) including, but not limited to:

- Give notice of the meeting and post agendas as otherwise required by the Brown Act;
- In each instance in which notice of the teleconferenced meeting is given
 or the agenda for the meeting posted, must also give notice as to how the
 public may access the meeting and provide comments. The agenda shall
 identify and include an opportunity for all persons to attend via a call-in
 option or internet-based service option;
- Conduct the meeting in a manner that protects the statutory and constitutional rights of the parties and the public appearing before the legislative body:
- Stop the meeting and take no further action if there is a disruption in the broadcasting of the meeting until such time as the broadcast can be restored;
- Cannot require that public comments be submitted in advance of a meeting and must provide an opportunity for the public to address the legislative body and offer comment in real time;
- Notwithstanding Government Code section 54953.3, which prohibits
 requiring a member of the public to register as a condition to attendance
 at a meeting of a legislative body, an individual desiring to provide public
 comment through the use of an internet website, or other online platform,
 not under the control of the local legislative body (e.g., Zoom), that
 requires registration to log in to a teleconference may be required to
 register as required by the third-party internet website or online platform
 to participate.
- Cannot close the public comment period until the public comment time specified on the agenda has passed and cannot close the ability to register to speak until a reasonable amount of time has passed. If no time is specified on the agenda, must allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment

In addition, on September 21, 2021, Dr. Robert Levin, Ventura County Health Officer, issued a recommendation to continue practicing social distancing measures throughout Ventura County communities, including to continue to implement 100 percent remote meetings of all legislative bodies in Ventura County, to prevent and minimize the spread of COVID-19.

III. <u>Preliminary 2022 Meeting Schedule:</u>

For the Year 2022, should the RRB opt to return to in-person meetings, the RRB Regular Meetings will be held on the following dates:

- Wednesday, February 16, 2022
- Wednesday, May 18, 2022
- Wednesday, August 17, 2022
- Wednesday, November 16, 2022

In-person meetings are typically held at the Ventura County Government Center, Hall of Administration, 800 S. Victoria Avenue, Ventura, CA 93009, Third Floor, Multipurpose Room. Alternative meeting locations may potentially be explored by RRB Staff at the discretion of the RRB.

If the RRB adopts Resolution RRB21-001 (Exhibit 1) and opts to continue meeting virtually as authorized by AB 361, it must meet to make the required findings every 30 days thereafter. For the remainder of Year 2021 and beginning of Year 2022, should the RRB opt to continue meeting virtually, the RRB Regular Meetings will be held on the following dates:

- Wednesday, December 15, 2021
- Wednesday, January 12, 2022
- Wednesday, February 9, 2022
- Wednesday, March 9, 2022
- Wednesday, April 6, 2022
- Wednesday, May 4, 2022
- Wednesday, June 1, 2022

IV. RECOMMENDED ACTIONS:

Staff is recommending the RRB take the following actions regarding this item:

- 1. **CONDUCT** the public hearing, **RECEIVE** oral and written testimony, and **CONSIDER** the Planning Division Staff report;
- 2. **PROVIDE** feedback on the preliminary 2022 meeting schedule and location; and
- CONSIDER adoption of Resolution RRB21-001 (Exhibit 1) authorizing remote teleconference meetings of the Rent Review Board for a 30-day period pursuant to Government Code section 54953, subdivision (e), of the Ralph M. Brown Act.

A RESOLUTION OF THE VENTURA COUNTY MOBILE HOME PARK RENT REVIEW BOARD AUTHORIZING REMOTE TELECONFERENCE MEETINGS OF THE VENTURA COUNTY MOBILE HOME PARK RENT REVIEW BOARD FOR A 30-DAY PERIOD PURSUANT TO GOVERNMENT CODE SECTION 54953, SUBDIVISION (e), OF THE RALPH M. BROWN ACT

WHEREAS, the County of Ventura ("County") is committed to preserving and nurturing public access and participation in meetings of the Ventura County Mobile Home Park Rent Review Board ("Board");

WHEREAS, Government Code section 54953, subdivision (e), of the Brown Act, authorizes the legislative body of a local agency to use remote teleconferencing in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953, subdivision (b)(3), subject to the existence of certain conditions:

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558:

WHEREAS, it is further required that state or local officials have imposed or recommended measures to promote social distancing;

WHEREAS, such conditions now exist in Ventura County, specifically, Governor Gavin Newsom declared a state of emergency in response to the COVID-19 pandemic on March 4, 2020 ("State of Emergency");

WHEREAS, on September 21, 2021, Dr. Robert Levin, Ventura County Health Officer, issued a recommendation to continue practicing social distancing measures throughout Ventura County communities, including to continue to implement 100 percent remote meetings of all legislative bodies in Ventura County, to prevent and minimize the spread of COVID-19 ("Recommendation to Promote Social Distancing");

WHEREAS, the Board does hereby find that it has reconsidered the circumstances of the State of Emergency, the State of Emergency remains active and continues to directly impact the ability of its members and attendees to meet safely in person, and that the Ventura County Health Officer, Dr. Robert Levin, continues to recommend measures to promote social distancing to minimize the spread of COVID-19 including that all legislative bodies in Ventura County

continue to meet remotely, as further explained in his Recommendation to Promote Social Distancing, which has not been rescinded and remains in effect;

WHEREAS, the Board does hereby find that it shall conduct its meetings without compliance with Government Code section 54953, subdivision (b)(3), as authorized by subdivision (e), of Government Code section 54953, and that the Board shall comply with the requirements set forth in Government Code section 54953, subdivision (e)(2); and

NOW, THEREFORE, BE IT RESOLVED, by the Board as follows:

Section 1. The foregoing recitals are true and correct.

Section 2. Staff supporting the Board are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including conducting open and public meetings of the Board in accordance with Government Code section 54953, subdivision (e), and other applicable provisions of the Brown Act.

Section 3. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of December 17, 2021, or such time the Board adopts a subsequent resolution in accordance with Government Code section 54953, subdivision (e)(3), to extend the time during which the Board may continue to teleconference without compliance with Government Code section 54953, subdivision (b)(3).
