## APPEAL PERIODS

- A. Appeals of all entitlements, permits, and administrative decisions shall be filed within 10 calendar days following the date of approval, conditional approval, denial, or date of the alleged error. (Section 8111-7.3)\*\*\*
- B. An appeal of a Planning Commission decision shall be filed within 10 calendar days following the date a decision was rendered.
- C. An appeal of an environmental decision shall be filed within 10 calendar days following the date a decision was rendered.
- \*\*\* If the end of an appeal period falls on a weekend or holiday, the appeal must be filed by 5:00 p.m. on the first working day thereafter.
