Consider Downgrade of Landmark to Point of Interest

The Ventura County Cultural Heritage Board (CHB) will consider downgrading the Santa Gertrudis Asistencia (Chapel) Monument from a Ventura County Landmark (currently Landmark No. 11) to a Ventura County Point of Interest. The County of Ventura's proposed action is based on information that the property no longer appears to meet the criteria for a Ventura County Landmark. The property is located as follows:

Along North Ventura Avenue, 0.3 mile north of City of Ventura water purification plant (5895 N Ventura Avenue, Ventura, CA 93001), within California Department of Transportation right of way

You are hereby notified of a public hearing to be held before the CHB to review this consideration. At this hearing, there may be presentations by the property owner(s) and staff with an opportunity for any interested person or authorized agent to comment on the item.

Applicant: County of Ventura Resource Management Agency, Planning Division, 800 S Victoria Avenue, #1740, Ventura, CA 93009

Property Owner: California Department of Transportation (Caltrans), District 7, 100 S Main St., Los Angeles, CA 90012

Environmental Review: This application is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15308 which is consistent with a Class 8 exemption (Actions by Regulatory Agencies for Protection of the Environment).

Notice is hereby given that the County Ordinance Code authorizes the CHB to downgrade the above property from a Ventura County Landmark to a Ventura County Point of Interest once a notice is given to the property owner and a public hearing is held on the matter. The CHB is the final decision-making authority on the downgrade where the property owner has no objection.
