5. <u>APPROVAL OF MINUTES</u>

Board Member Francis made a motion to approve the November 15, 2023, meeting minutes. Board Member Rosenbaum seconded the motion. Motion passed 5-0.

6. <u>COMMENTS FROM BOARD MEMBERS</u>

Board Member Francis reported that he recently assisted a mobile home park resident in the City of Oxnard with a lot line dispute amongst neighbors.

Board Member Brooks expressed concern about how mobile home parks in the county have handled recent rains. Board Member Brooks noted that he plans to observe some parks for himself. Board Member Francis stated that most mobile homes are on a raised foundation which adds an element of protection from flooding. Board Member Brooks noted his concern with flooding in parking areas.

Board Member Martinez reported that she was assisting one mobile home park resident with a requirement of the Mobilehome Residency Law that park owners provide notice to any resident organization formed by homeowners in the mobilehome park prior to sale of the park. Next, Board Member Martinez reported that her mailing address had changed, and she was no longer a resident of a mobile home park.

Chair Hundley noted that any public inquiries received by Board Members should be directed to Planning Division staff.

#### 7. <u>COMMENTS FROM PLANNING STAFF</u>

Dillan Murray, staff, reported that Board Members are required to complete ethics training every two years and requested that certificates of completion be submitted to staff when completed. Next, Mr. Murray reported that the Planning Division approved seven ministerial rent increase applications for 2024, with two currently pending. Finally, Mr. Murray reported that earlier this year, Planning Division staff completed the process of verifying all eight senior mobile home parks have a majority of senior residents. This is required to be done every two years to ensure this source of affordable housing stock is being maintained.

Board Members requested information be distributed on the list of parks with an approved rent increase for 2024 and on the list of senior parks in the county.

#### 8. <u>ADJOURNMENT</u>

The next hearing of the RRB will be held Wednesday, May 22, 2024 at 1:00 p.m. At 1:17 p.m., the RRB was adjourned.
